## RESEARCH PRESENTATIONS AT ACADEMIC CONFERENCES

Renz has prepared and presented more than 100 research papers and presentations at academic and professional conferences since 1993. Approximately 60 percent of these have been peer-reviewed for presentation at academic conferences.

#### GRANT AND DEVELOPMENT SUPPORT

Renz has successfully secured more than \$7 million in foundation and government grants to support nonprofit capacity building projects and programs since 1993. More than \$6 million of this funding supported nonprofit leadership and capacity building in the Midwest.

## PROFESSIONAL SERVICE AND OFFICES (past 15 years)

Renz has served in an extensive number of executive, board and service roles in a range of academic and professional leadership and capacity building organizations, societies, and associations. He served in multiple leadership roles for the Nonprofit Academic Centers Council and the United Philanthropy Forum (formerly the Forum of Regional Associations of Grantmakers). He has served as a faculty tenure reviewer for a dozen universities, as well as several graduate degree program external review teams, and a state council reviewer for the National Endowment for the Humanities. He also has served as an officer and board member for the Association for Research on Nonprofit Organizations and Voluntary Action (ARNOVA), the premier nonprofit research association.

## **CONFERENCE LEADERSHIP**

Renz has served as director or co-director for more than 20 academic and professional development conferences in the Midwest, and he has served in conference planning roles for six national conferences. Half of these conferences have been convened to provide nonprofit leader development and capacity building for Kansas City and Midwest nonprofit organizations and their leaders.

# PROFESSIONAL PRESENTATIONS, WORKSHOPS, AND PROGRAMS

Renz regularly speaks to conferences and programs serving nonprofit leaders and executives in the U.S. and, especially, in the Midwest. For each of the past twenty years, Renz has delivered about fifteen workshops, speeches and professional development programs for associations and organizations. Further, Renz regularly engages in board development initiatives with an average of about ten individual nonprofit organizations each year. Since, 1993, Renz has worked with more than 150 individual nonprofit boards of directors (largely in the Midwest).

#### COMMUNITY LEADERSHIP: MIDWEST CENTER FOR NONPROFIT LEADERSHIP

A pivotal element of Renz' work during his 29 years with UMKC has been to develop, grow, and sustain the work of the Midwest Center for Nonprofit Leadership to ensure that it is a valued contributor to the nonprofit leadership community of Kansas City and a respected member of the academic and research community of the U.S. and beyond. In recognition of his service, Renz received a "Special Lifetime Achievement Award" from a Kansas City regional nonprofit membership association, Nonprofit Connect, in 2019. Since 1993, the center has served nearly 100,000 nonprofit leaders, executive and volunteer (e.g., board members), and has become known as among the most community-engaged of university-based nonprofit academic centers in the U.S.
